Dodo Karsay is a human rights consultant and researcher with a focus on the experiences and rights of historically marginalized groups, particularly LGBTQI people, asylum seekers and persons with disabilities. Dodo's research work has included mapping the experiences of LGBTQI asylum seekers in Hungary and of LGBTQI persons with disabilities in the context of movement building.

Dodo is a queer-feminist activist, currently serving as a board member of the Hungarian LGBT Alliance and previously as the spokesperson of Budapest Pride. Dodo graduated from Central European University in Human Rights, and Eötvös Loránd University in Sociology and English. Dodo also pursued studies at the Afro-American Studies Department of the University of California Los Angeles.
